


The word Ethics is derived from the Greek word 'ethos' which means character and from Latin word 'Mores" which means customs. It can be defined as the moral

In ancient India, the instructions of a teacher (guru) to a student (disciple) would start as follows: Let your conduct be marked by right action, including study and teaching of the scriptures; by truthfulness in word, deed and thought; by self-denial and the practice of austerity; by poise and self-control; by performance of the everyday duties of life with a cheerful heart and in unattached mind. ... Deviate not from the path of good. Revere greatness." In Taxila,

later in Nalanda, Fès, Rabat and Al-Azhar, still later in Paris and Oxford, instruction emphasised moral and ethical values.

This was because formal education, although available to a restricted few, was organised around religious institutions. Education was thought to be a cultural good for individual moral development and was to have very little to do with economic wellbeing or material progress. Education had to provide principally the codes of behaviour, as exemplified in the instructions above, initiation to the value system and an understanding of the ultimate objective of life in terms of spirituality. The ultimate goal of the whole process of education was to unravel the 'truth', to manifest "the perfection already in man", to combine knowledge with compassion and efficiency with moral excellence. Ethical dilemmas arise when one's own ethical standards conflict with those who have some other entity. Aristotle was one of the first great philosophers to study the subject. To him, ethics was more than a moral, religious or legal concept. To determine what is ethically good for the individual and for the society, he said, it is necessary to posses three virtues of practical wisdom: temperance, courage and justice.

CONCLUSION:

Teachers at all levels of education should focus on imparting quality education. It is the prime duty of the teacher to bring optimum development among the students. Teachers' should show an equal level of dignity to his profession, institution, students, colleagues and parents. Teachers'
